Warrants Round Up

The Gastonia Police Department (GPD) in collaboration with the Gaston County Sheriff's Office (GCSO) and Gaston County Police Department (GCPD) successfully detained fourteen people in a two day initiative to arrest suspects with outstanding warrants. The warrants were for various crimes, such as failure to appear in court, carrying a concealed weapon without a permit, extortion and robbery with a dangerous weapon.

“This two day initiative was successful in helping to keep our communities safe,” said Chief Adams of the GPD. “Our officers worked diligently with area law enforcement to apprehend the suspects in a well organized, strategic response to our multiagency round-up program.”

Those arrested included:

- 2) Steven Scott Cline, 46 (DOB: 7/18/1962), Gastonia, two counts of failure to appear; one count of paraphernalia; one count of resisting arrest; and two counts of robbery with a dangerous weapon.
- 3) Michael Anthony Davis, 44 (DOB: 2/8/1964), Gastonia, one count of assault on a female.
- 4) Michael Kevin Duncan, 19 (DOB: 12/25/1989), Gastonia, one count of failure to appear, one count of resisting a public officer, and one count of carrying a concealed weapon.
- 5) Derek Anthony Jackson, 18 (DOB: 6/16/1990), Gastonia, two counts of failure to appear.
- 6) George Isaiah Jagers, 19 (DOB: 9/14/1989), Gastonia, two counts of failure to appear.

- 7) Phayne Lipscomb, 31 (DOB: 7/24/1977), Gastonia, one count of assault on a female, one count of unauthorized use of vehicle, and one count of misdemeanor larceny.
- 8) William Joseph McCormick, 43 (DOB: 9/29/1965), Gastonia, one count of extortion.
- 9) Justin Lee Mosley, 20 (DOB: 2/25/1988), McAdenville, one count of failure to appear.
- 10) Nathan Dwain Ray, 23 (DOB: 2/1/1985), Dallas, warrant from Lancaster, S.C.
- 11) Rodney Lee Rhodes, 35 (DOB: 5/7/1973), Dallas, one count of failure to appear on a manslaughter charge.
- 12) Domino Marquis Smith, 20 (DOB: 4/26/1988), Gastonia, two counts of failure to appear.
- 13) Jason Lamar Spencer, 29 (DOB: 2/5/1979), Gastonia, one count of failure to appear.
- 14) Natreco Jerome Spencer, 21 (DOB: 8/5/1987), Gastonia, two counts of failure to appear.

This program is only one of many successful programs the GPD, GCSO and GCPD work together closely on. Other programs include the multi agency Gang of One Gaston, and Gaston County Gang Initiative along with various community improvements thru associations such as Habitat for Humanity.
