Things to know:

- If the backflow assembly fails the test, the customer has 10 days to have the device repaired or replaced.
- **Only** licensed plumbers can repair approved backflow prevention assemblies.
- Installation of new backflow devices or replacement of backflow devices must meet current building specifications and must be an approved assembly.
- Each customer shall maintain a complete, written record of every repair and test of each backflow prevention assembly for a period of no less than three (3) years.
- Please note that prices and services do vary.
