Introduction

The Community Development Block Grant (CDBG) Program is a flexible program that provides states and units of local government with financial resources to develop viable communities. Grants are provided annually on a formula basis. With the use of these funds, local governments are able to providing decent housing, a suitable living environment, and opportunities to expand economic opportunities, principally for low- and moderate-income persons.

The *City of Gastonia* is an entitlement community and Participating Jurisdiction (PJ) that annually receives Community Development Block Grant (CDBG) Funding and HOME Investment Partnership Program (HOME) funding from the U.S. Department of Housing and Urban Development (HUD). This is the <u>second amendment</u> to the <u>fourth and fifth years</u> of the 2015-2019 Consolidated Plan.

Purpose

The purpose of this proposed amendment to the 2015-2019 Consolidated Plan is to:

- 1. Fulfill federal requirements, and
- 2. Provide information to the residents of the City of Gastonia.

An amendment is necessary to allow the change in projects proposed for the use of federal HUD funding as required by *Title 24 of the Code of Federal Regulations (CFR), Section 91.505*. The purpose of this amendment is to describe the City's additional outlined projects.

Citizens Participation

Citizen participation is a requirement of the CDBG Program (24CFR91.105). The City executed the Citizen Participation Plan and provides opportunity for public input throughout the development and approval of the amendment. Citizens are encouraged to engage in public discussion and are notified of both the public hearing and public comment period via the local newspaper publication, *The Gaston Gazette*, and postings on the City's website http://www.cityofgastonia.com on the events calendar and on the Housing and Neighborhoods Division web page.
